Most humble and respect I have the honour to state that on 09/03/2026 at around 8:00 pm some unknown persons suspected to be members of KCP/MFL G5 Lamyamba enter inside the worksite (Integrated Sewerage Project) located at Kongba Uchekon and one of member threaten and slap two labourers (1) Md. Abu Sayed and (2) Ramjan Ali. They also given a piece of threat sheet written as KCP/MFL G5 Whatsappno. 8119959918 directing to call back within 5 days. Besides, they also threaten to vacate the worksite within 30 days otherwise it will be exploded by bombs. The incident was happened during the absence of Police Security Personnel from Reserved Line Imphal East.

Moreover, on 20.02.2026, repeated phone calls have been received from an unknown number (9863867596) enquiring about their demand given to the worker on a piece of paper and warning us to stop the ongoing work until their demands are finalized. Most of our workers are from outside the state, and they are deeply disturbed and apprehensive due to the threats received.

It is therefore kindly take up necessary legal action against culprits and punish them according to provision of laws
