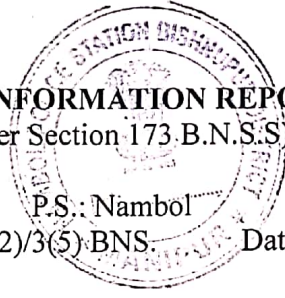

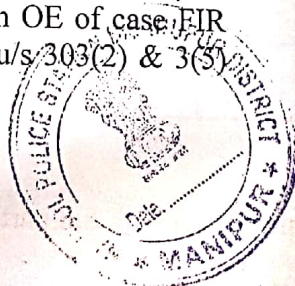
It is, therefore, requested you to kindly trace out my stolen Honda Activa DLX and take up necessary legal action against the unknown culprits at the earliest.

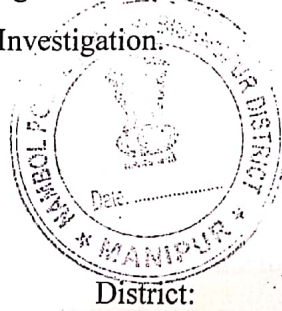
