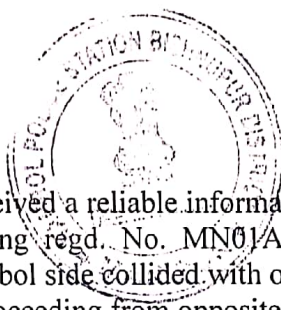

Today i.e. 01/05/2025 at 6:45 pm received a reliable information that, on the same day at about 6:40 pm one motorcycle Royal Enfield bearing regd. No. MN01AF-4636, ridden by an unknown rider proceeding from Oinam side towards Nambol side collided with one Honda Activa bearing regd. No. Nil, ridden by an unknown rider which was proceeding from opposite direction at Nambol Thongkha in front of R.K Fish & Livestock feed shop along Tiddim road, due to rash and negligent driving on the part of the both vehicle riders. As a result of which, the unknown rider of Honda Activa sustained injuries and evacuated to hospital for medical treatment. The Honda Activa was badly damaged and motorcycle Royal Enfield was also partly damaged.

Hence, a suo moto case under FIR No. 24(05)2025 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
