Today i.e. 06/05/2025 at 08:35 pm received an information that on the same day at about 08:30 pm one Royal Enfield bearing regd. No. MN01AL-5411, ridden by an unknown rider which was proceeding from Nambol side towards Imphal side collided with one Maruti Van bearing regd. No. MN01S-4617 driven by one unknown driver which was proceeding from the opposite direction at Meitram, in front of CDS Debeshor Automobile along Tiddim road due to rash and negligent on the part of the rider of Royal Enfield and the driver of Maruti Van. As a result of which, the unknown rider and driver of both vehicles sustained injuries on their persons and evacuated to hospital for medical treatment. Both the involved vehicles were also badly damaged.
