Subject: Application for lodging FIR against armed men for trespass, attempt to murder and kidnapping at gunpoint.

Respected Sir,

I respectfully submit this application to request the registration of an FIR regarding a serious incident that occurred at my residence in Kingkin village, CCPur on 17th February, 2026 at about 9 PM. On the said day, three(3) armed men forcefully trespassed into our house. They were carrying Automatic Rifles and attempted to attack my husband Mr. Lunminlen Haokip. Fearing for his life, my husband managed to escape through the back door.

After failing to catch my husband, the armed men forcefully took my son Mr. Seijalaithang hostage. They fled the scene in a white Hyundai Creta car with unknown registration number. They took my son along with them against his will.

My son was about to appear in his 12th Class Board Examination, and this traumatic incident has created extreme fear and mental distress in his mind. Although he was released after about one hour with threat for his life, the incident has severely affected his mental peace and concentration. The entire incident has also created panic and a chaotic environment in our locality, causing fear and insecurity among residents. This act of criminal trespass, attempt to murder, kidnapping at gunpoint and criminal intimidation endanger life of my family members.

I therefore humbly request you to kindly register an FIR against armed men involved in this incident and take strict legal action against them as per the law. So that we can prevent such incident happening in the future.

The delay in submitting this application occurred because my husband sustained injuries while escaping from the attack and required immediate medical attention and treatment. At the same time, my son was about to appear in his examination, and due to the severe trauma and fear caused by the incident, we had to focus on his medical care and mental well-being so that he could appear for his examination properly. Additionally, due to certain unavoidable family circumstances, we were unable to approach the police station immediately.

Kindly treat this matter as urgent and take necessary action to ensure justice and maintain peace in our area.
