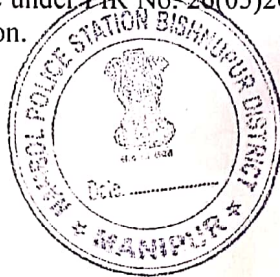

Today i.e. 06/05/2025 at 10:30 pm received an information that on the same day at about 10:25 pm one Royal Enfield bearing regd. No. MN04G-4395, ridden by an unknown rider which was proceeding from Nambol side towards Bishnupur side met an accident with one Tata Truck bearing regd. No. NL07AA-2127 driven by one unknown driver which was proceeding from the same direction at Maibam Chingmang along Tiddim road due to rash and negligent on the part of the rider of Royal Enfield and the driver of Tata Truck. As a result of which, the unknown rider and pillion rider of Royal Enfield sustained injuries on their persons and evacuated to hospital for medical treatment. The involved Royal Enfield was badly damaged and the Tata Truck was partly damaged.

Hence, a suo moto case under FIR No. 26(05)2025 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
