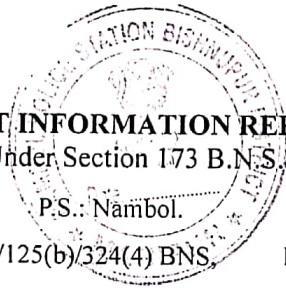

12. First Information contents:

Today i.e. 07/05/2025 at 03:25 pm received an information that on the same day at about 03:20 pm one Kia Seltos car bearing regd. No. MN01AG-6604, driven by an unknown driver which was proceeding from Imphal side towards Nambol side collided with one Diesel Auto rickshaw bearing regd. No. MN01F-0650 driven by one unknown driver, which was proceeding from the same direction, while the driver of Kia suddenly crossed from eastern side towards western side of the road at Phojing Awang near Light House along Tiddim road. The incident is happened due to rash and negligent driving on the part of the both vehicle drivers. As a result of which, the driver and three unknown passengers of the Diesel Auto rickshaw received injuries on their persons and evacuated to hospital for their medical treatment. Both the involved vehicles were badly damaged.

Hence, a suo moto case under FJR No. 27(05)2025 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
