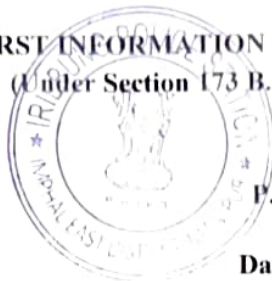

Sir,

I have the honour to report that today i.e. the 18th March, 2026 at about 6:40 a.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the presence of one woman active member of the outfit KCP at Kongba Ucheckon area of Imphal- East District. Based on the said information and with the permission/authorization of the authority, a team of CDO/IE Unit along with woman police personnel conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 7:40 a.m.

In that, one suspicious unknown woman was detained for spot verification at a house i.e. Kongba Makha Ucheckon, Imphal East District. On verification, the detainee identified herself as one **Thokchom Devarani Devi (43 years) D/o Thokchom Kaoba Singh of Kongba Makha Ucheckon, Iriblung Police Station, Imphal East District**. One mobile phone was found and recovered from her possession. On further verification, the detainee stated that she is an active member of the outfit KCP (PWG) joined through one Mr. SK of KCP (PWG) in the month of March, 2024 and got her basic military training for seven days under the command of one Mr. John of KCP (PWG). The detainee further stated that she is presently working under the command of one Mr. Kiran of KCP (PWG) and involved in extortion of money from various govt. offices and general public for raising their party fund.

So, the detainee was arrested from her residence i.e. Kongba Makha Ucheckon, Imphal East District at 8:01 a.m. and seized **one mobile phone (Redmi 9A) bearing IMEI 862851050018780 & 862851052198788 along with one Airtel SIM card having phone no. 9233984640** from her possession at the spot i.e. Kongba Makha Ucheckon, Imphal East District at 8:05 a.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against her.
