Subject: Report.

Sir,

I have the honour to report that today i.e., the 20th March, 2026 at about 5:00 a.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the concealment of arms, ammunitions and explosive at Keirao Wangkhem Village and its surrounding foothill area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and 33 AR conducted a search operation at the said area and its surrounding foothill area of Imphal East District under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, MPS Addl. SP (Ops)IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 6:00 a.m.

In that, two nos. of plastic polythene bags suspected to be containing arms and ammunitions were found hidden in a bush at the foothill of Keirao Wangkhem village near T. B. Hospital, Imphal East District. On opening the polythene bags, the undernoted arms and explosives were found inside the polythene bags:

- 1) **1(one) no. of country made Pistol marked as '04331' with magazine.**
- 2) **1(one) no. of country made Pistol marked as '04888' with magazine.**
- 3) **1(one) no. of country made Pistol marked as '09278' with magazine.**
- 4) **1(one) no. of country made Pistol marked as '031878' with magazine.**
- 5) **1(one) no. of 12 bore country made single barrel gun.**
- 6) **1(one) no. of .303 rifle marked '07651'**
- 7) **1(one) no. of country made rifle**
- 8) **3(three) nos. of INSAS Rifle magazine.**

Accordingly, the above recovered arms, ammunitions and explosives along with the two plastic polythene bags were seized from the foothill of Keirao Wangkhem village near T. B. Hospital, Imphal East District at 6:27 a.m. by observing due formalities.

The seized arms, ammunitions and explosives are being handed over to you for further legal procedures.
