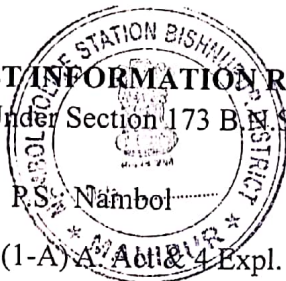

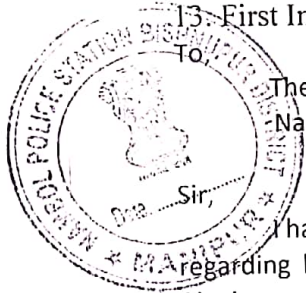

Sir,  
I have the honour to report that today i.e. 14/05/2025 based on a specific input from own source regarding loitering of some armed miscreants and cached of arms & ammunition at fringe areas of Aigejang and Leimaram Uyok forest under Nambol-PS, a joint teams of CDO-BPR led by self assisted by ASI M. Inaotomba Singh, a team of NBL-PS along with a column of 33 AR under the command of Shri P. Sanjoy Singh, MPS, DSP(CDO-I)/BPR and Sub.Y. Shaktishen Singh OC/CDO-BPR along with executive magistrate, SDC/Oinam under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP (Ops), Bishnupur and under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-Bishnupur conducted an extensive search operation in the said area.

Some suspected areas were cordon from 5.30 am by a team led by ASI M. Inaotomba Singh from southern side, a column of 33 AR led by Maj. Devarshi from western side, a team of NBL-PS from eastern side, self with my team from Northern side and search started. In the operation, the following arms and explosives items were recovered found concealed under bushes at the adjoining area of Aigejang and Leimaram Uyok forest.

**Details of the recovered items:**

1. 01(one) .303 Rifle bearing no. 3528K with 01(one) magazine.
2. 01(one) .303 Sniper (Modified) bearing no. MM81239.
3. 02(two) SBBL Gun bearing no. MS30091:2017 & MS80141:2016.
4. 01(one) No. 36 HE hand grenade.
5. 02(two) No. 75 Detonator, MK-II.
6. 01(one) 40mm Lathode grenade.
7. 01(one) No. 80 WP Grenade.
8. 01(one) Tear Smoke Grenade.
9. 03(three) Stun Shell (Normal).
10. 01(one) Tear Smoke Shell (Soft Nose).
11. 02(two) Anti-riot Rubber bullets.
12. 02(two) Three ways Tear Smoke Grenade.

The above recovered items were seized at 6.45 am by observing proper formalities in presence of Shri. Akoijam Punsheeba Meitei, MCS, SDC-Oinam and the operation was closed at 7.15 am.
