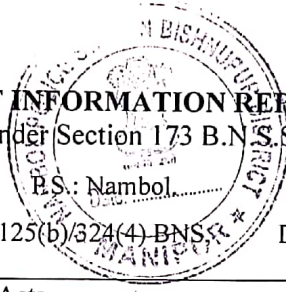

12. First Information contents:

Today i.e. 18/05/2025 at 03:00 am received an information that on the same day at about 02:50 am one motorcycle Yamaha R15 (V4) bearing regd. No. MN01AQ-5288, ridden by an unknown rider which was proceeding from Nambol side towards Bishnupur side knocked down one male pedestrian at Nambol Sabal Leikai near the entrance of IP Bora hotel along Tiddim road due to rash and negligent driving on the part of the rider of Yamaha R15 (V4). As a result of which, the unknown pedestrian and the rider of the Yamaha R-15(V4) received injuries on their persons whereas the pillion rider of motorbike also received minor injury and evacuated to hospital for their medical treatment. And the involved motorcycle was also partly damaged.


Hence, a suo moto case under FIR No. 30(05)2025 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
