Madam,

With due regard and respect, I have the honour to report the following facts. That, yesterday i.e. 22/03/2026 at around 4:30 pm while self along with my cousin brother namely Maibam Zunaid (14) s/o Maibam Rafi returned home from Keirao, when we reached at Kairam Palli, Maning Palli near Trio English School my Honda Active was forcibly stopped by Md. Azamal (20) s/o Md. Faya r/o Keirao Makting Makha Leikai and pull out my activa key. Further, he along with Md. Faya (42) s/o (L) Md. Abdul Latif, Md. Muskan (20) s/o Md. Abo, Md. Siraj (20) s/o Md. Janab Khan and their associates all residence of Keirao Makting Makha Leikai assaulted me and my cousin brother Zunaid black and blue by using deadly weapons like sticks without giving any reasons. They also shouted why you people come here. At the meantime my brother namely Maibam Rahish (17) s/o Maibam Rafi and Maibam Asif (22) s/o Maibam Rahaman tried to control the matter. However, the said accused persons assaulted them also by using sticks without giving any reason. As a result of which we received serious injury on our persons and evacuated into JNIMS, Hospital Poromapt for our medical treatment.

It is therefore requested to take necessary legal action against the above mentioned accused persons for the end of justice.

For which act of your kindness, I remain grateful to you.




