Today i.e. 21/05/2025 at 06:50 pm received an information that on the same day at about 06:40 pm one Hoda active bearing regd. No. MN01AQ-7996, ridden by an unknown rider which was proceeding from Nambol side towards Imphal side collided with one Mahindra Bolero bearing regd. No. MN01W-9190 driven by unknown driver which was proceeding from opposite direction at Kodompokpi Lamkhai along Tiddim road due to rash and negligent driving on the part of the rider and driver of both vehicles. As a result of which, the rider and pillion rider of the Honda Activa received injuries on their persons and evacuated to hospital for their medical treatment. And the involved vehicles were also partly damaged.


