At around 1415 hrs, the party intercepted three individuals on SehlonJoupi road at Hengshi travelling in a Bolero pickup (Regd No ML08J8289). Upon detailed search of the individuals and veh, 04 bricks (packages) containing approx 40000 WIY tablets were recovered from the innerside of the dashboard of the veh.
