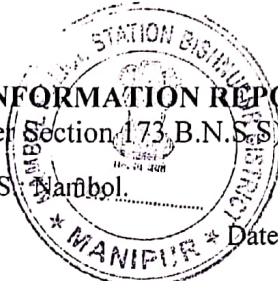

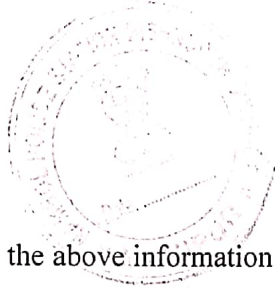

Today i.e. 27/05/2025 at 10:40 pm received an information that on the same day at about 10:35 pm one Maruti Van bearing regd. No. MN01W-2496 driven by one unknown driver which was proceeding from Nambol side towards Imphal side met a self accident by dashing to the road divider at Malom in front of Malom Oil Depot along Tiddim road due to rash and negligent driving on the part of unknown driver of Maruti Van. As a result of which the unknown driver of Maruti Van received sustained injury on his person and evacuated to hospital for medical treatment. The involved Maruti Van was also badly damaged.
