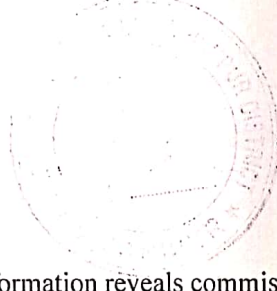

Today i.e. 06/06/2025 at 01:05 pm received an information that on the same day at about 01:00 pm one Tata Tipper 407 bearing regd. No. AS06BC-3933, driven by one unknown driver which was proceeding from Oinam side towards Imphal side dashed to the backside of one Honda Activa bearing regd. Nil ridden by one unknown rider which was also proceeding on the same direction at Nambol Bazar in front of Leima Book Store along Tiddim road due to rash and negligent driving on the part of unknown driver of Tata Tipper 407. As a result of which, the unknown rider and three pillion riders of Honda Activa received injuries on their persons and evacuated to hospital for their medical treatment. And both the involved vehicles were also partly damaged.
