13. First Information contents:

Today i.e. 09/06/2025 at 9:00 an information was received regarding an incident linked to the ongoing 10-days bandh called by Arambai Tengol (AT) starting from 07/06/2025, in protest against the arrest of AT Army Chief Commander Asem Kanan by the CBI.

At approximately 8:50 am, as Army vehicles were enroute from Bishnupur to Imphal, agitators attempted to block them near Keinou. Upon reaching Oinam Bazar junction, bandh supporters attacked the convoy using slingshots and blunt force weapons. As a result, one Army Personnel sustained a head injury, and two vehicles suffered damage to windshields and body panels.

Hence, a regular case under FIR No. 38(6)2025 NBL-PS U/S 189(5),191(1),190,195(1),223(a),117(2),351(2), 125(a) & 324 (3),3(5) BNS is registered on suo moto for investigation.
