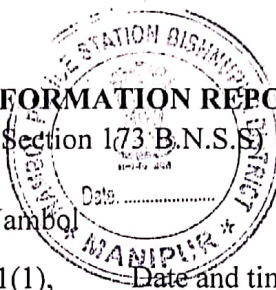

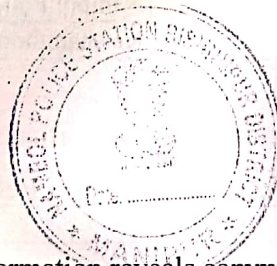
13. First Information contents:

Today i.e. 09/06/2025 at 11:25 am received an information that on the same day at around 11:20 am, a large number of unknown miscreants suspected to be members/bandh supporters called by Arambai Tengol (AT) have blocked the road at Nambol Thongkha area along Tiddim road by burning tyres and logs by violating total curfew imposed by the District Magistrate, Bishnupur, protesting for the arrest of AT Army Chief commander Asem Kanan by the Central Bureau of Investigation (CBI) regarding the prevailing situation in the state.

Immediately, a strong team of District police led by SP-BPR, along with ASP(L/O)/BPR, ASP(OPS)/BPR, ASP(BPR), Shri Wangkhomba Okramcha, MPS, OC/CDO-BPR, Dy.SP/CDO-1/BPR, Dy.SP/CDO-2/BPR, SDPO/BPR, OC/NBL-PS and other 4-5 mobile teams of CDO personnel, rushed to the site and directed them to self-disperse the agitation and blocking of road. However, the agitators numbering around 100 suddenly form an unruly mob and started pelting stones towards the security forces and in the melee even gherao one Addl. SP/BPR Shri Wangkhomba Okramcha, MPS and his escort party and assaulted them using deadly weapon sharp stones etc. In that, Shri Wangkhomba Okramcha, MPS and one of his escort personal received head injuries on their person and evacuated to nearby District Hospital for medical treatment. Instantly after taking due permission from the Executive Magistrate presence at the spot, the strong Police team fired large number of mock shells and later fired some blank rounds in the air as a last resort to control the unruly mob and eventually was able to dispersed and controlled the mob as agitators fled away in different nearby IVRs.

Hence, a regular case under FIR No. 39(6)2025 NBL-PS U/S 189(5),191(1),190,195(1),223(a),109(1),324(3),117(2),351(2),3(5) BNS is registered on suo moto for investigation.

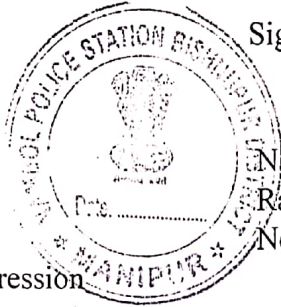
