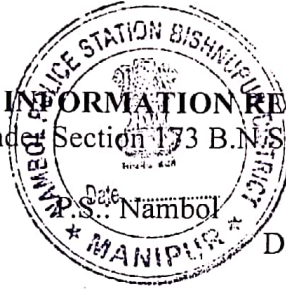

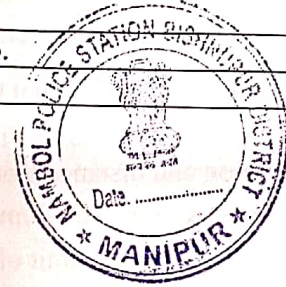

I have the honour to report that on 10/10/2021 at around 3:30 pm one Mr. Akoijam Rocky Singh, aged about 40 years S/O Late AK. Kullajit Singh a resident of Maklang, Imphal West District, Manipur came to my house and approached me with a request to hire my Bolero Maxitruck bearing registration no. MN01G-7080 for some time. As he is known to me, I accepted his request and hand over my vehicle to him. He assured and promised me that my vehicle would be returned as soon as his work is completed. However, after a few months when his work is completed, he failed to return my vehicle inspite of my repeated request till date.

I contacted Mr. Rocky several times and requested him to return back the vehicle so that the matter may be settled amicably. However, he still refused to comply with my request. Moreover, he kept concealed my vehicle in collusion with his associates and still failed to let me know the whereabouts of my vehicle. This circumstance/situation has caused significant distress, anxiety and inconveniences to me.

In the light of the above facts and narratives I respectfully request you to take necessary legal action against the Mr. Rocky Singh and his associates at the earliest.

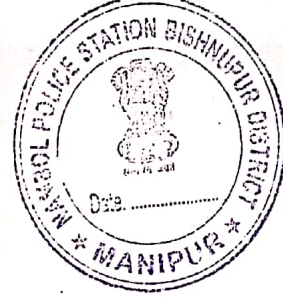
