Today i.e. 10/01/2026 at 7:50 am received an information that on the same day at about 7:40 am one Tata Magic B/regd. No. MN01W-2513 Driven by one unknown Driver which was proceeding Imphal side towards Nambol side collided with one Bus bearing regd. No. MN01-1818 driven by unknown driver which was proceeding opposite direction i.e Nambol side towards Imphal side at Malom Boroimakhong near Bridge along tiddim road due to rash and negligent driving on the part of unknown drivers of both vehicles. As a result of which, the unknown driver and some passengers of Tata Magic received injuries on their persons and evacuated to hospital for medical treatment. Both the involved vehicles were partly damaged.
