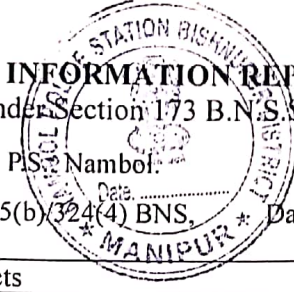

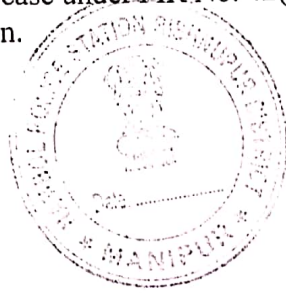

Today i.e. 27/06/2025 at 06:05 pm received an information that on the same day at about 06:00 pm one TVS Jupiter bearing regd. No. MN01V-4140, ridden by an unknown rider which was proceeding from Imphal side towards Nambol side collided with one KTM Duke bike bearing regd. No. MN06SE-4509 driven by one unknown driver which was proceeding from the opposite direction at Utlou Heibi Makhong near waiting shed along tiddim road, due to rash and negligent on the part of the both riders of TVS Jupiter and KTM Duke bike. As a result of which, the unknown riders of both vehicles sustained injuries on their persons and evacuated to hospital for medical treatment. Both the involved vehicles were also partly damaged.

Hence, a suo moto case under FIR No. 42(06)2025 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
