I have the honour to report that on 23/03/2026, while conducting random frisking and checking at Mao Police check post along NH-2 about 1 km North-West of Mao-PS by a combine team of QAT Team Mao PS, A/109Bn CRPF and B Coy 16AR. During frisking and checking, at around 2:30 am, one A-Star bearing Regd. No. HR05AG-9844 coming from Imphal side towards Dimapur was stopped by the teams for checking.

While checking the vehicle, the driver was found in a suspicious manner. On preliminary enquiry the driver admitted to possess contraband drugs.
