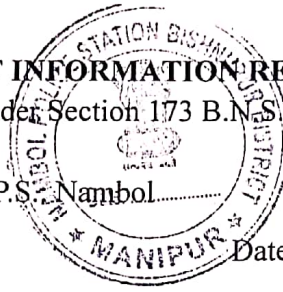

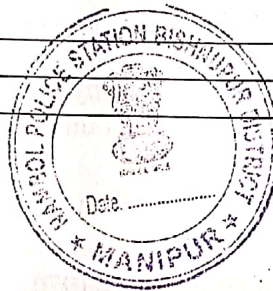

Sir,

I, the undersigned have the honour to report that on 19/06/2026 late night at around 10:30 pm the following persons namely 1) Hawaibam Rahul Singh (31) years S/o Late. H. Shamu Singh of Awangjiri Mamang Leikai, 2) Naorem Sunder Singh (35) years S/o N. Kokil Singh of Naorem Makha Leikai, 3) Seram Inaocha Singh (32) years S/o S. Modhumangol Singh of Ishok Makha and 4) Chungkham Lalit Singh (28) S/o Late. Ch. Mangi Singh of Leimapokpam Khunpham Awang Leikai who identified themselves as a member of Arambai Tengol (AT) have entered forcefully/house trespass into my residence and they overpower and abducted my two sons namely 1) Sarangthem Rojen Singh (29) years and 2) Sarangthem Roshan Singh (28) years and they further brutally dragged both my sons out from our house and took them to the nearby courtyard of one Hemantakumar Hawaibam (60) years S/o Late. H. Ibocha Singh of Awangjiri Mamang Leikai. Thereafter they brutally assaulted them by kicking and punching and suspected to have used some unknown deadly weapons too. As a result of which both my sons sustained bleeding injuries on their body parts. Moreover, the above mention hooligans illegally detained both my sons in that house until the intervention from local residents who heard the commotion and gathered at the spot. On seeing the large number of local folks gathered the accused persons then fled from the scene, leaving both injured and traumatized. Immediately, I along with local people evacuated them at CHC, Nambol for medical treatment. However, the concerned doctor of CHC, Nambol referred both of them at RIMS, Hospital Lamphel for further medical treatment. I could not report the matter to police well in time as I along with all the family members were busy attending medical treatment for both of them at Hospitals.

It is therefore requested you to kindly take up necessary legal action against them at the earliest which attempt to kill my sons and caused grievous injuries to them.

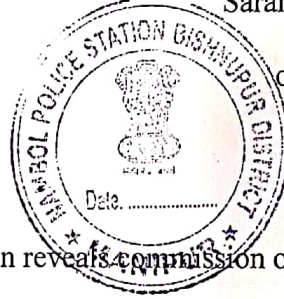
