One Angom Baby Singh, S/o (L) A. Bira Singh of Thangmeiband Polem Leikai, I/W reported to OC/IPS stating that he had submitted an application dated 27th August, 2021 to the Deputy Commissioner, Imphal West District under Section 53 (2) r.w Section 81(2) of the M.L.R. & L.R Act, 1960 praying for ascertaining the boundary of his homestead lands under Patta Nos. (i) 142,1233 (Old) corresponding to 58(New) covered by C.S. Dag No. 9012 measuring an area of .0263 hectare and (ii) 90/142,1233 AngS (Old) corresponding to 58/966(New) covered by C.S. Dag No. 9012/9273 measuring an area of .0263 hectare, both are situated within the Revenue Village No. 90-Thangmeiband, Imphal West District, Manipur and to evict any encroachers therefrom (Copy of application dated 27th August, 2021 is enclosed as Annexure-I). That, the Deputy Commissioner, Imphal West District entrusted the case to the Addl. Deputy Commissioner, Imphal West who further entrusted to the S.D.O Lamphel. Further, S.D.O Lamphel entrusted the case to the Sub-Deputy Collector, Imphal West (C)-I for taking necessary action. That, accordingly, Sub-Deputy Collector, Imphal West (C)-I summoned both the parties and heard 2(two) times before the Hon'ble Court of the Sub-Deputy Collector, Imphal West (C)-I on 21/02/2025 & 07/03/2025 (Copies of Orders dated 21/02/2025 & 07/03/2025 are enclosed as Annexure-II) That, as per Order dated 07/03/2025 passed by the Sub-Deputy Collector, Imphal West (C)-I, date for conducting Land Demarcation was fixed on 22/03/2025. Accordingly, the Sub-Deputy Collector, Imphal West (C)-I made requisition to the Superintendent of Police, Imphal West District, Manipur, Imphal copy marked to the Officer-in-Charge, Imphal West Police Station requesting for providing Police assistance during the Land Demarcation as above mentioned above. That, on 22/03/2025 at about 09.00 a.m a team of Field Staff of SDC/IW (C)-I along with the concerned S.K and neighbouring pattadars and a team of Police of Imphal Police Station have reached and started spot verification from the eastern side of the patta lands of the petitioner. However, while field pickup was started in the area of western side of the petitioner, many womenfolk of the locality numbering more than 30 who were hired by the following opposite parties have obstructed the lawful demarcation process conducted by the Field Staff of SDC/IW (C)-I (Public Servants) by threatening the lives of Public Servants with an intention to create public nuisance if the demarcation is continuing. So, the demarcation could not be proceeded further (Copy of Report dated 22/03/2025 prepared and submitted by Field Staff of SDC/IW (C)-I is enclosed as Annexure-III).

Thus, the above mentioned opposite parties along with unknown womenfolk of the locality have committed the offence under section 221 of BNS by obstructing the official duties discharged by the Field Staff of SDC/IW (C)-I along with the concerned S.K and neighbouring pattadars and a team of Police of Imphal Police Station on 22/03/2025. Further, the above mentioned opposite parties have committed the offence under section 329 of BNS by encroaching the lands of the petitioner without any valid documents. Whereas, the undersigned petitioner could not submit the report in time by awaiting the legal action to be taken up by the concerned Sub-Deputy Collector, Imphal West (C)-I namely Shri Yunnam Dhanendra Singh after receiving the report dated 22/03/2025 submitted by the Field Staff of SDC/IW(C)-I mentioned above and when enquired about the status of Demarcation case, he directed him to approach the womenfolk of the locality (Meira Paibi) which is a direction given by an Officer who is working as Presiding Officer in the Hon'ble Court of the Sub-Deputy Collector, Imphal West (C)-I.
