

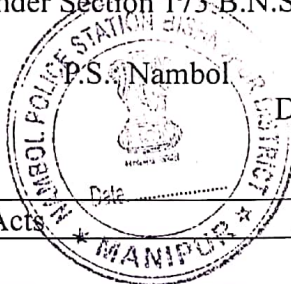

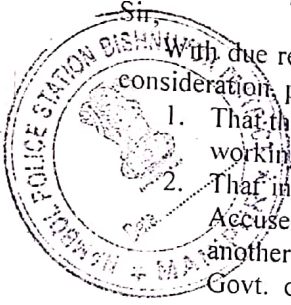

Subject: - Request for taking up proper legal actions against the accused Laishram Ajitkumar Singh presently serving as Rifleman in the Manipur Rifles for the illegal actions of cheating and the misappropriation of the money entrusted to him by the present Complainant.

Sir,
With due regards, the undersigned Complainant have the honour to state the following lines for your kind consideration, please: -

1. That the present complainant is one of the unemployed youth who desires to live a self-sustained life by working sincerely.
2. That in the early part of the year 2025, the present Complainant came to know the above-mentioned Accused person through his cousin brother as the said cousin brother and the Accused were known to one another. On their first meeting, the Accused introduced himself as an Officer of the Indian Railways, Govt. of India and the Accused enquired the present Complainant about his present status. The complainant also introduced himself as a part time Contractor. On hearing that, the Accused proposed the Complainant to do contract works in the Indian Railways. The Accused lured the Complainant by saying that he could help the Complainant in getting contract works in the Railways since, he was working as an Officer in the Indian Railways.
3. That due to frequent proposal/approaches of the accused to do contracts works in the Indian Railways, the Complainant started to trust the Accused and enquired about the working style of the contract works in the Indian Railways. The accused told the Complainant that it would be better for the Complainant to hand over some amounts to him which he is going to join his service soon.
4. That believing the story of the Accused, on 02/02/2025 at @10:12am the present Complainant handed over an amount of Rs 5,00,000/- (Rupees five lakhs) only in cash to the Accused at Mekola Bazar which was said to be used as Deposit amount for future contract works of the Indian Railways. Thus, the Accused induced the Complainant to hand over the said amount of Rs 5,00,000/- (Rupee five lakhs) making him believe that the Accused is an Officer in the Indian Railways. After taking the said amount, the Accused remained silent.
5. That recently, when the complainant enquired about the Accused, he came to know that the Accused is/was a Cheater and he was not an Officer of the Indian Railways as alleged by him while inducing to hand over the above-mentioned amount. Later it has come to the knowledge of the Complainant that the accused is a Rifleman in Manipur Rifles and he has no connection or nexus with the Indian Railways. Thus, the Accused cheated the Complainant and has misappropriated the money entrusted to him by the Complainant. The acts of the Accused amounts to cheating and misappropriation of Money of the Complainant.



In the light of the aforesaid facts and circumstances, your Good Self may graciously be please to register an FIR against him for the ends of justice.

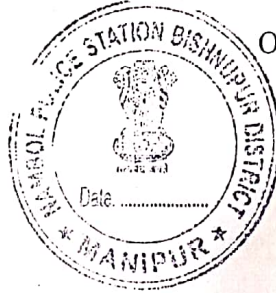
