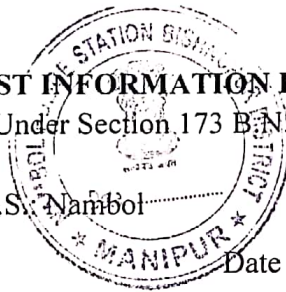

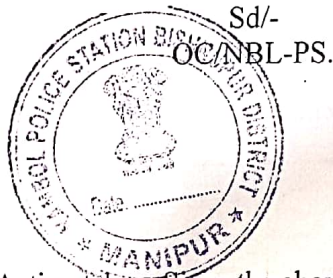
Subject: - Report.

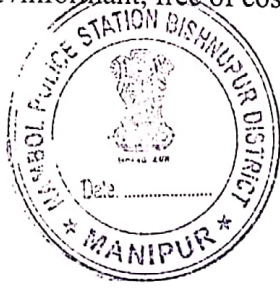
