Subject: Formal complaint regarding theft and criminal breach of trust by an employee.

Sir,

I am writing to formally report an incident of theft that occurred at my restaurant, Union Café, located at Utlou Awang Leikai, near the power house. On the morning of December 3rd, 2025, at approximately 6:00 a.m and again on 10th January 2026 @ 3 am by an employee named Serto Micheal Kom, who was serving as an Assistant Chef, exploited his authorized access to the premises to commit a dishonest act. The accused stealthily removed movable property belonging to the café, specifically one Red MI 9 Power mobile phone valued at approximately ₹20,000 and two refill gas cylinders valued at approximately ₹8,000. The total estimated loss resulting from this theft is ₹28,000. This unlawful act was captured clearly on the café's CCTV surveillance footage, which I am prepared to provide to the authorities as evidence. The actions of the accused constitute a clear case of theft and criminal breach of trust by an employee under Sections 303 and 316 of the Bharatiya Nyaya Sanhita (BNS), 2023. It has come to my attention that the accused is currently active on Facebook.

Therefore, I earnestly request your office to register a case also request your assistance in recovering the stolen property and taking necessary legal action against Serto Micheal Kom.
