It is therefore, requested kindly to investigate this matter, identify the miscreant and take necessary action to prevent further thefts in the area.

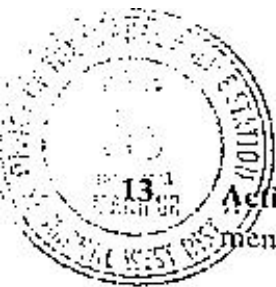



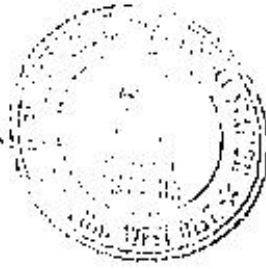
