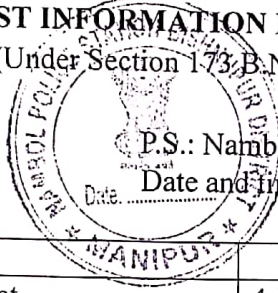

Sir,

I have the honour to report that today i.e 26/07/2025 at around 4:30 am, received a reliable information from our own source regarding hideout of some arms and ammunitions suspected to be concealed by some unknown arm miscreants. Immediately, a combined team of CDO/BPR including self-assisted by SI. Ph. Sunil Singh, ASI. H. Robash Singh, HC, W. Sanathoi Singh & Hav.15007648 R.K Manjit Singh of CDO, BPR under the command of Inspt. Y. Motilal Singh, OC/CDO-BPR along with NBL-PS team led by Inspt. A. Nabakanta Sharma, OC/NBL-P.S including SI. K. Jiban Singh, ASIL. Taibanganba & HC N. Gopen Singh assisted by a column of 33 AR and a team of CRPF, A-157 under the supervision of Shri. Amarjit Singh Lamabam, Addl. SP (Ops), Bishnupur and under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-Bishnupur in presence of Shri Akoijam Punshiba Meitei, SDC/Executive Magistrate, Oinam conducted an extensive search operation at Uyok Forest, Leimaram Makha Maning and adjoining areas after giving due information to the concern authority. During the course of search of operation, the team successfully recovered the following huge cache of Arms and ammunitions including explosives and other incriminating articles which were suspected to be kept concealed by the unknown miscreants from a Nala near Uyok Forest, Leimaram Makha Maning.
