Today i.e. 12/08/2025 at 09:45 pm received an information that on the same day at about 9:40 pm one Toyota Taisor bearing regd. no. MN01AX-7984, driven by one unknown driver which was proceeding from Nambol side towards Imphal side dashed to the back-side of one Bajaj Pulsar bearing regd. no. MN04D-1388 ridden by one unknown rider which was proceeding same direction at Malom Makha in front of Brilliance School along Tiddim road due to rash and negligent on the part of the driver of Toyota Taisor. As a result of which, the unknown riders of Bajaj Pulsar sustained injuries on his person and evacuated to hospital for medical treatment. Both the involved vehicles were also partly damaged.
