A joint operation was launched by a coin comprising of str 01-01-40 ex COB Changpol and team of chandel police (6 person) w,e,f 2200 hrs on 29/3/2026 to search the area. Stops were placed and the search party was divided into two groups to thoroughly search the thickly vegetated area near the Indo Myanmar border. After extensive search of the area. At around 0845 hrs on 30th march, 2026. One of the parties found a suspicious patch and on carrying detailed search. A hidden cache containing war like stores (WLS) was unearthed at GR-706978. The operation was continuing to check for presence of similar caches in the suspected area. After thorough search of the area and no further recovery.
