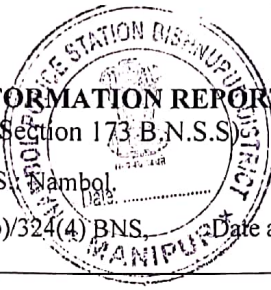

12. First Information contents:

Today i.e. 17/09/2025 at 09:45 pm received an information that on the same day at about 9:40 pm one Royal Enfield 350 bearing regd. No. MN01AF-8668, ridden by one unknown rider which was proceeding from Nambol side towards Imphal side head on collided with one Honda Activa bearing regd. No. MN01AC-4674 ridden by one unknown rider which was proceeding from opposite direction at Phoijing Awang near Chaninglairembi Service Station (Oil Pump) along Tiddim road due to rash and negligent driving on the part of both the riders. As a result of which, both the unknown riders and one pillion rider of Royal Enfield 350 sustained severe injuries on their persons and evacuated to nearby hospital for medical treatment. Both the involved vehicles were also badly damaged.

Hence, a suo moto case under FIR No. 61(9)2025 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
