12. First Information contents:

Today i.e. 10/10/2025 at 10:31 pm, received an information that on the same day at @10:30 pm one Tata Truck bearing registration No. WB-65D-7858, driven by one unknown driver which was proceeding from Bishnupur side towards Imphal side dashed to one iron pole which attached and installed CCTV cameras of Home Dept. erecting on the road side in front of Nambol-PS gate. And subsequently due to the uncontrollable impact, the said Tata Truck again dashed to the south-western fencing wall of Nambol-PS, near the entrance gate of NBL-PS along Tiddim road. The incident happened due to rash and negligent on the part of the unknown Tata Truck driver. As a result of which, the unknown driver and co-driver received injuries on their persons and evacuated to hospital for medical treatment. The involved vehicle was partly damaged and the fencing wall got totally damaged & collapsed. The CCTV cameras installed at the iron pole was also damaged.

Hence, a suo moto case under FIR No. 64(10)2025 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
