13. First Information contents:

Today i.e. 18/10/2025 at 9:10 pm, received an information from Inspt. A. Nabakanta Sharma, OC/NBL-PS that on the same day at around 9:00 pm he along with 2<sup>nd</sup> teams of NBL-PS led by ASI L. Taibanganba Singh, conducted a Lagao drive as a preventive measure within the AOR of NBL-PS using two police vehicles. During the drive at Oinam IVR, around 70-80 Lagao gamblers were found gathered at Oinam Mamang Leikai. The police teams seized two sets of Lagao dice from the spot. In retaliation, the unknown gamblers formed an unruly mob and started pelting stones at the police teams, causing damage to the windshields and front light of the two police vehicles. Despite giving repeated warnings to stop throwing stones, the mob continued their aggression. As a last resort to disperse the crowd, the police teams fired some rounds into the air. Subsequently, the District police control Room, Bishnupur was informed to dispatch reinforcement teams of CDOs to the spot. Accordingly, CDO teams comprising Q-61, Q-57, Q-59 and Q-75 proceeded toward Oinam IVR. However, before reaching the place of occurrence, the CDO mobile vehicle of Q-61, led by ASI Netrajit Singh, was hit by stones thrown by unknown miscreants resulting in damage to its windshield. Later, three individuals namely (i) Mutum Premkumar Singh (45) years S/o M. Manglemba Singh of Oinam Mamang Leikai (ii) Ngangom Srinivash Singh (20) years S/o Ng. Angouba Singh of Oinam Mamang Leikai and (iii) Ngangom Angouba Singh (49) S/o (L) Ng. Nongyai Singh of Oinam Mamang Leikai were picked up from the spot and brought to this PS for further proceeding. After a short while, the situation was brought under control and normalcy was restored.

Hence, a suo moto case under FIR No. 66(10)2025 NBL-PS U/S 132, 190,191(2), (3),324(3), 221, 3(5) BNS has been registered for investigation.
