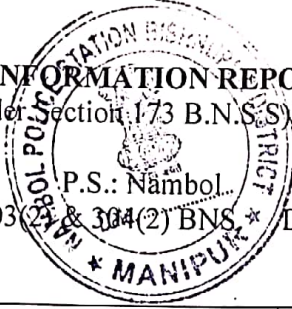

Sir,

Most humbly and respectfully, I the undersigned, wish to bring the following fact to your immediate attention for necessary legal action under the prevailing criminal law that on 31st October 2025 at around 3:05 pm as usual my son has dropped off at home from his school, Life School located at Ghari, by the school Van. Immediately upon his arrive, it was noticed that his gold ear-rings (left and right), which were worn earlier, were missing from his ears. The approximate value of the missing property is about Rs. 18,000/- (Rupees Eighteen thousands) only. The act is suspected to be one of theft or Snatching, as the ear-ring were forcefully or dishonestly removed from the possession of my son without his consent during his commute. it is strongly suspected that the gold ear-rings were stolen/snatched by the school van drive namely Wahengbam Rimabosh Singh (22) S/o W. Nobo Singh of Kakyai Makha Leikai.

It is therefore kindly register this report as a First (FIR) under the relevant provisions of the Bharatiya Nyaya Sanhita (BNS),2023, likely BNS Section 304 (Snatching). Immediately initiate a thorough investigation into the matter, summon the suspected van drive and take custody of the stolen property and taken up necessary legal action against the above individual at the earliest.
