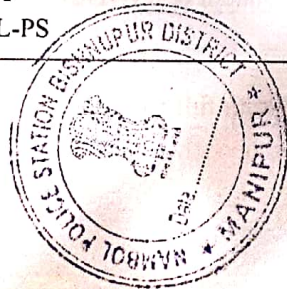
It is, therefore, requested you to kindly trace out my Honda Activa 5G Std, and take up necessary legal action against the unknown culprit at the earliest.

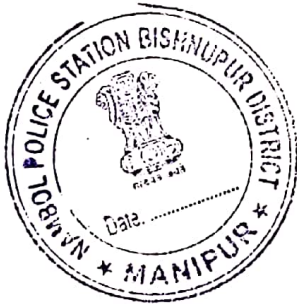
