Sir,

I have the honour to report that I am a member artist of the Sangeet Natak Mandir, Nambol for the past 20 (twenty) years. During this period, I have been actively participated in the welfare and developmental activities of the said committee.

Regretfully, I came to learnt that my signature was fraudulently forged on the "Managing Committee Meeting" held on 18th October 2023 at the house of Chandam Jadumani Singh S/o (L) Ch. Ador Singh of Nambol Awang, for selection of new Managing Committee. I strongly believed that the act of forging my signature was done in collusion and conspired by the undernoted individuals:

1. Haorongbam Ishorchandra Singh, S/o H. Bishwarup Singh
2. Khwairakpam Herojit Singh, S/o (L) Kh. Ibohal Singh
3. Chongtham Rameshwor Singh, S/o (L) Ch. Tomba Singh
4. Chandam Jadumani Singh, S/o (L) Ch. Ador Singh
5. Leiphrakpam Surjit Singh, S/o (L) K. Damu Singh
6. Smt. Soibam Bimota Devi, W/o (L) S. Iboton Singh

All of the above-named individuals are residents of Nambol Awang Leikai, Bishnupur District. It has been ascertained that the resolution papers bearing my forged signature was unlawfully used and submitted as valid records to a government authority, thereby constituting a serious act of forgery and misrepresentation.

In connection with this matter, an inquiry was conducted by the District Co-Operative Officer, Bishnupur on 1st October 2024, which officially confirmed the occurrence of the said forgery. A copy of the official inquiry report is enclosed herewith for your kind perusal and reference. Moreover, I along with other previous member of the committee tried many times prior before submitting this report for amicable settlement but they all remain deaf ears and pay heed to my humble appeals.



In view of the above facts and circumstances, I most respectfully request that necessary legal action be initiated at the earliest against the aforementioned individuals in accordance with the relevant provisions of law.
