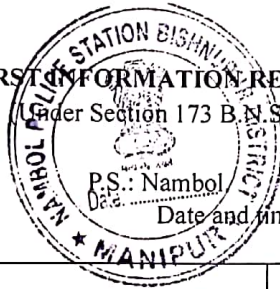

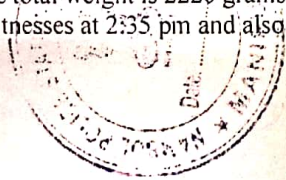

Subject: Report.

Sir,

With due regards, I have the honour to state that today i.e. 21/11/2025 at 1:30 pm, a joint operational team was conducting a random Mobile Vehicle Check Post (MVCP) along the stretch of Tiddim Road between Malom and Oinam. This operation was initiated in connection with the bandh (General Strike) called by COCOMI to protest the organization of the Sangai Festival in the State. The team comprised personal from the Nambol Police Station (NBL-PS), led by Inspector A. Nabakanta Sharma, OC/NBL-PS, ASI. T. Premananda Singh & HC. N.Gopen Singh of NBL-PS and the MN Sector QAT and Range Sector QAT of the CRPF, led by myself. The entire MVCP was conducted under the overall supervision of SP/BPR, Thokchom Shankar Deba.

While conducting checks ahead of the Nambol NAKA point at around 2:15 pm, one Maruti Suzuki Wagon R car grey in colour bearing regd. No. DL3CCB2182 which was proceeding from Churachandpur side towards Imphal side along Tiddim road was observed driving in a suspicious manner toward the checking teams. The vehicle was signaled to halt and was successfully stopped in front of the MS Surash Car Servicing Centre, Phoiing Makha, opposite Bethel English School. On spot verification, the driver and one co-driver identified themselves as (i) Anil Thakuri (29) S/O Late. Tilak Bahadur thakuri of Makuri Asang, PS- Kangpokpi, District- Kangpokpi, Manipur (driver of the vehicle), (ii) Krishna Kafle (35) S/O Gopal Kafle of Toribari, PS- Kangpokpi, District- Kangpokpi, Manipur (Co-driver). Due to their suspicious nature and in order to check their body and belongings, they were given option whether they wanted to check their bodies and belongings in front of a Gazetted Officer or Magistrate. In that they opted to be searched in presence of Executive Magistrate. Accordingly, contacted concern Executive Magistrate Shri Th. Shambhunath, SDC/Executive Magistrate, Nambol. Thereafter, the Executive Magistrate reached within a short period at the spot and their bodies and belongings were searched and checked minutely. While checking the vehicle, 57 (fifty-seven) nos. of soap cases suspected to Heroin No.4 were found kept concealed beneath the running board of the said Wagon R car. The suspected contraband Heroin No.4 were seized in presence of the Magistrate and witnesses at 2:35 pm and also packed and sealed at the spot by observing necessary formalities. Further, seized one



Aadhar Card bearing No. 889903832329, one mobile Redmi 14 Pro along with one SIM card bearing No. 9863413251, Indian currency RS,2400/- (rupees two thousand four hundred) 500x4=2000 & 200x2=400/- and one Wagon R VXI car bearing regd. No. DL3CCB2182 at 2:45 pm on production by Anil Thakuri (29) S/o Late. Tilak Bahadur Thakuri of Makui Asang, PS- Kangpokpi, District- Kangpokpi, Manipur by observing due formalities. After that, one Aadhar card bearing No. 455054620312, one mobile SAMSUNG Galaxy A14 along with one SIM card bearing mobile No.8787894207, one mobile phone One Plus Nord 2, 5G along with two SIM cards bearing Nos. 9612708297 & 9862968561, one SBI ATM Card bearing No. 4591560279128672 of Krishna Kafle and Indian currency Rs. 120/- (one hundred twenty) were also seized at 2:50 pm on production by Krishna Kafle (35) S/Gopal Kafle of Toribari, PS- Kangpokpi, District- Kangpokpi, Manipur by observing due formalities.

Accordingly, the accused persons namely Anil Thakuri and Krishna Kafle were arrested at 3:00 pm, and 3:05 pm respectively from the spot by observing necessary formalities. On preliminary interrogation, they disclosed that, they are drug peddlers and the said items are contraband Heroin No.4 which was brought from one Iche of Churchandpur for selling to some prospective buyer at Kangpokpi.

Accordingly, the arrested persons and the seized items were handed over to Nambol Police for taking further necessary action.


