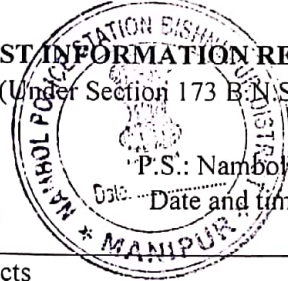

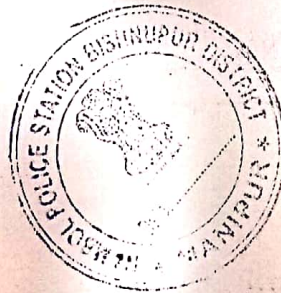
With due respect, I, the undersigned have the honour to report that today i.e. 26/11/2025 at around 3:30 pm, received a reliable input from own sources and corroborated with the inputs provided by 33 AR and 2<sup>nd</sup> Mahar regarding hideout some arms and ammunitions suspected to be concealed by some arm miscreants at Heigrujam area. Based on the input, a combined teams comprising of Nambol Police Station led by myself and ASI L. Taibanganba Singh, ASI. T. Premananda Singh, HC. N. Gopen Singh including lady police personnel, a column of 33 AR led by Maj. Devrishi Sengar, one column of 2<sup>nd</sup> Mahar led by Capt. Arun Sonalia and a section of F-157 Bn. CRPF, led by Inspt. Chandra Bushan, KVK Utlou under the command of Inspt. A. Nabakanta Sharma, OC/NBL - P.S, and under the overall guidance of SP-Bishnupur immediately rushed to the said area and conducted search operation in the said area.

During the course of search operation, one suspected individual was detained on her suspicious manner in front of her house gate at Heigrujam Mayai Leikai. On the spot verification, she disclosed and identified herself as one Nongmaithem Radha Devi (46 years) W/o. Nongmaithem Nabachandra Singh of Heigrujam Mayai Leikai and informed her for conducting house search at her house in presence of lady police personnel. In that, she also allowed to conduct house search. Accordingly, conducted search at her house and while searching, one plastic sack multi colour printed with roses was found concealing inside an empty Oil Tin, kept at her kitchen room. When opening the said plastic sack, found one pistol with a magazine which has been kept concealed by repping a baby hooded pink colour full sleeve shirt, and twelve (12) numbers of live ammunitions were also found in a black colour polythene bag within a lime green colour polythene bag. On further examination, she disclosed that, the said arm and ammunitions were handed over by some unknown miscreants since three/four months back. So, seized the said unauthorised items at 4:15 p.m and also arrested her at 4:20 pm respectively from the spot by observing necessary formalities.

The arrested person along with the seized items is handed over to you for taking further necessary legal action against her.
