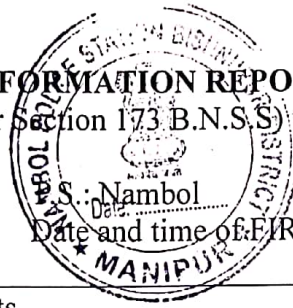

Subject:- First Information Report(FIR). Report on theft of school property from PM Shri School, Oinam Hindu Primary School, Bishnupur District, Manipur.

Sir,

I, the undersigned, Headmistress of Oinam Hindu Primary School, Oinam, Bishnupur District, Manipur, hereby lodged this First information Report (FIR) regarding a theft that occurred within the premises of our school.

On 08/12/2025 at around 9:00 am, it was found that five (5) benches from the classroom and fifteen (15) bags of cement stored for school use under the PM shri School scheme were stolen from the premises of the PM Shri School, Oinam Hindu Primary School, Bishnupur District, Manipur. The stolen items were essential for the functioning and development of the school infrastructure, and their theft has caused serious inconvenience to the students and staff. The incident appears to have taken place during the intervening night of 6<sup>th</sup> & 7<sup>th</sup> December, 2025 and the stolen materials were discovered missing upon inspection. This act of theft has not only disrupted the school's activities but also caused loss to government property intended for educational development.

I kindly request you to register a case under the appropriate sections of law, investigate the matter thoroughly, and take necessary action to recover the stolen items and bring the culprits to justice.

- (i) Five (5) Classroom benches worth of Rs- 10,000/-
- (ii) Fifteen (15) bags of cement worth of Rs-8,700/-
