Today i.e. 14/12/2025 at 06:50 pm received an information that on the same day at about 06:40 pm one Suzuki Access bearing regd. No. MN06SE-2201, ridden by an unknown rider which was proceeding from Nambol side towards Bishnupur side along Tiddim road dashed to the back side of one ECO van bearing regd. No. AS01DJ-9029 which was already parked on the Eastern roadside of Tiddim road at Maibam Chingmang, due to rash and negligent driving on the part of the rider of Suzuki Access. As a result of which, the unknown rider of Suzuki Access sustained injuries on his person and evacuated to hospital for medical treatment. Both the involved vehicles were also partly damaged.
