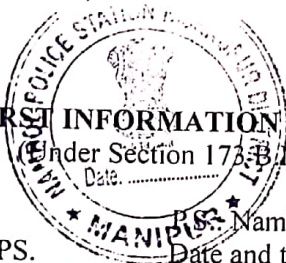

Subject: First Information Report (FIR) regarding lurking house-trespass and theft at
Leimapokpam Makha Leikai Panchayat Ghar.

Sir,

I, the undersigned, am writing to formally report a criminal incident that occurred at the Leimapokpam Makha Leikai Panchayat Ghar. On December 17, 2025, at approximately 7:45 p.m., it was discovered that unknown individuals had committed a targeted theft within the premises. The perpetrators are believed to have gained unauthorized entry into the office room by stealthily passing through a hole in the building's ceiling. Upon a thorough inspection of the site, the following items were confirmed stolen: One (1) VIP Chair, valued at approximately Rs. 5,000/-, Official NREGS (MGNREGS) Documents, which are of critical administrative importance. The loss of these documents has resulted in significant disruption to the essential functions of the Panchayat and has caused serious administrative inconvenience. Based on the nature of the entry and the items taken, it is evident that the act was committed with deliberate intent.

Therefore, I request that you register this case under the following sections of the Bharatiya Nyaya Sanhita (BNS), 2023: Section 331(1): Lurking house-trespass. Section 305(a) & (e): Theft in a residential house or building used for the custody of property. Section 3(5): Acts done by several persons in furtherance of common intention.

I would like you to kindly investigate into the matter at the earliest and to recover the stolen official records and apprehend the individuals responsible.
