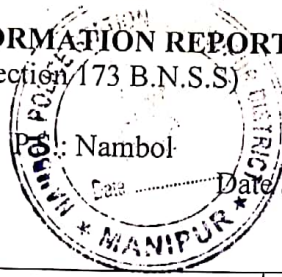

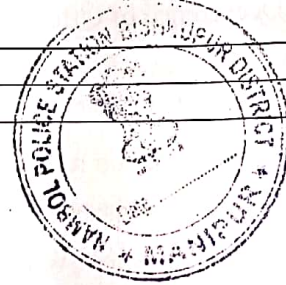

Subject: - Report of fraud and prayer for legal action under Section 318& 336 of the BNS.

Sir,

I, the undersigned, have the honour to state the following few lines that, I am currently operate a jewellery shop at Nambol Bazar and have been doing so for the last several years. On December 4th, 2025 at around 4:30 Pm, an unknown youth came to my shop and purchased gold weighing one and half 'San' along with eight 'changing' totalling Rs- 53,160/- (Fifty- three thousand and one hundred sixty Rupees). The individual claimed he have no cash and requested to pay via G-Pay. Upon my acceptance he appeared to initiate the transaction and sent a confirmation message to my mobile phone from the number 6009652752. Relying on this digital confirmation, I allowed him to leave with the gold. However, upon subsequent verification of my bank records, I discovered that the amount was never credited to my account. When I contacted the individual at the aforementioned mobile number to resolve the matter, he used to intimidate language, stating I could take any action, I wished but he would not return the gold or the money. It is evident that the accused had a dishonest intention to chat me from the onset.

It is therefore requested you to kindly registered a case and initiate necessary legal proceedings under sections 318(2)(4) and 336(2)(3) of BNS against the culprit to ensure the recovery on my property and the delivery of justice.
