Today i.e. 28/12/2025 at 1:20 pm received an information that on the same day at about 1:15 pm one Honda Activa bearing regd. No. MNO1AF-2426, ridden by an unknown female rider which was proceeding from Kangmong Tongbram side towards Nambol side along Kangmong IVR collided with one Tata 407 Tipper bearing regd. No. MN01AA-6323 which was proceeding from opposite direction at Kangmong Tongbram near crematorium along Kangmong IVR, due to rash and negligent driving on the part of the rider and driver of both vehicles. As a result of which, the unknown female rider of Honda Activa sustained injuries on her person and evacuated to hospital for medical treatment. Both the involved vehicles were also partly damaged.

Hence, a suo moto case under FIR No. 89(12)2025 NBL-PS u/s 281/125(b)/324(4) BNS has been registered for investigation.
