First Information contents:

Today i.e., on 16/01/2026 at around 11:00 a.m., when the Officer-in-Charge of Somdal Police Station namely Inspt. Krili James went to execute warrant of arrest issued against one person namely Firstman Rungsung (54 yrs) s/o Kapangkhui Rungsung of Talui village, issued by the court of the Hon'ble Session Judge, Ukhrul and while the OC (Officer-in-Charge) of Somdal Police Station was explaining the reason for executing the Warrant of Arrest to the mother of the accused, the accused/warrantee suddenly took out a knife which he kept concealed on his back and stabbed the OC Krili James on the chest with the knife. When the OC felt down on the ground injured, the accused charged towards the other police personnel with the knife. Seizing the opportunity, the OC escaped from the scene for his life shouting for help. The villagers came to his rescue and immediately evacuated him to Talui PHC (Primary Health Centre) and gave him preliminary treatment. The incident was reported to the higher authority. It was also learnt from local source that the accused was always in possession of a knife and he has a history of committing murder in the past as well. So, armed team from Ukhrul Police Station led by the OC namely Inspector Marchang Wungmahai and another armed team led by SDPO Jessami went to execute arrest of the culprit. The teams were divided into 4 (four) smaller groups and raided the house of the accused and nearby structures from different directions. When the group led by Inspector Marchang Wungmahai, OC Ukhrul PS approached towards the Eastern side of the house, the accused ran out of the house and jumped down a steep slope and ran towards the jungle. Inspector Marchang Wungmahai and his group members ran after him and tried to overpower him. When the accused was caught by Inspt. Marchang Wungmahai from behind, he turned around and attacked him with the knife inflicting atleast 3 (three) cut injuries on the hand of Inspector Marchang Wungmahai. The accused instead of surrendering himself, kept attacking Inspector Marchang Wungmahai with a deliberate attempt to murder him. But, clever moves of the Inspector Marchang Wungmahai averted receiving the fatal blows of the knife. So, in order to defend himself
