Sir,

I, the undersigned, hereby make the report against the above-named accused persons as follows:

1. That I am the owner and recorded pattadar in possession of the land under Dag No 1247 of patta No 78/614(old), 200 (new) Revenue village No 78-Changangei, IW and it is bounded by dag No 1244, 1246, 1248 and 1453 (Tiddim Road).

True copies of jamabandi and trace map are enclosed herewith and marked as Annexure A/1(i) and A/1(ii) respectively

2. That land under Dag No 1246 is bounded as follows:

North: by Dag No. 1245

South: by Dag No. 1248

East: by dag No 1247, and

West: by dag No 1249

3. That the above-named 6 accused persons forged the said map by extending line of dag No 1246 through my land under dag No 1247 upto the Tiddim road just to show that the said dag No 1246 touches the Tiddim Road. They filed application being Dem. Case No 60/SDC/IW(P) of 2025 dated 04/08/2025 to the SDC/ Patsoi for demarcation of land under dag No 1246 enclosing the said forged map and giving the false boundaries as follows:-

North: by the homestead of land of Sapam Nishikanta Singh (Dag No 1444)

South: by the homestead of Andy Mangsatabam (dag No 1247)

East:- by the Tiddim Road (Dag No 1453)

West:- by the homestead of Thangjam Budhajit Singh (Dag No 1249)

True copy of said application and forged map copy are enclosed herewith and marked as Annexure A/2 (i) and A/2(ii) respectively.

4. That the said accused persons forged the said map copy with the intention of cheating the concerned revenue officials and others including me and they used the said forged map and filed the said application for demarcation. Thus they have committed offence under Section 336(3) of the Bharatiya Nyaya Sanhita, 2023

I, therefore, request you to take legal action against the accused persons and punish them according to law.
