I have the honour to state that today i.e. 20/02/2026 at about 04:30 am, a reliable information was received from our own source and further corroborated from the information input provided by 31 AR regarding the presence of some active cadres of KCP (PSC) organization (a faction of KCP organization) an outlawed banned organization, in and around Tera Lukram Leirak area of Imphal West District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by Subedar L. Bikramjit Singh of CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at some suspected houses located at Tera Lukra Leirak area. During that one suspected person was detained from a house located at Tera Lukram Leirak for verification. On spot verification, the detainee identified himself as Chanambam Henba Singh (21 yrs.) @ Lanchenba S/o. (L) Ch. Dilipkumar Singh of Iroisemba Mang Hiden, Lane No. 10, Imphal West District, Manipur (who later identified himself as the resident of the said house of his in-laws).

During preliminary verification, he disclosed that he is an active member of KCP(PSC) organization led by s/s Chairman Ibungo Ngangom (a faction of KCP organization) and joined the said organization in the year 2024 through one Pari of KCP(PSC) organization from Lamdeng area. He also disclosed that he is working under the command of the above mentioned s/s Commander Pari.

Hence, he was arrested from the spot i.e. from the house of his in-laws located at Tera Lukram Leirak at 06:23 am by observing formalities.

From his possession, (i) one xerox copy of Aadhaar Enrolment Acknowledgement receipt bearing Enrolment No. 2009/14132/30038 was seized at the spot at 06:27 am by observing due formalities.
