I have the honour to state that today i.e. 21/02/2026 at about 10:45 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 A regarding the presence of some active cadres of KCP (PSC - Politburo Standing Committee) organization (a faction of KCP organization), an outlawed banned organization, in and around Takyel Khongbal area of Imphal West District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at some suspected houses located at Takyel Khongbal area. During that one suspected person was detained from a house located at Takyel Khongbal Lane No. 21 for verification. On spot verification, the detained person identified himself as Jany Kangjam (23 yrs.) @ Japan s/o Kangjam Telebrish of Takyel Khongbal, Lane No. 21, Imphal West District, Manipur (who later identified himself as the resident of the said house).

During preliminary verification, he disclosed that he is an active member of KCP(PSC) organization led by s/s Chairman Ibungo Ngangom (a faction of KCP organization) and joined the said organization in the year 2023 through one Jackson of KCP(PSC) organization from Lamdeng area. He also disclosed that he worked under the command of the above mentioned Jackson, s/s Commander of KCP(PSC) Koutruk camp.

Hence, he was arrested from the spot i.e. from his residence at 12:20 pm by observing formalities.

From his possession, (i) one Redmi 10A mobile handset along with one Jio SIM card bearing mobile no. 7005817275 (as disclosed by him) and (ii) one Aadhaar card bearing No. 2549 7958 6491 were seized at the spot at 12:26 pm by observing due formalities. -

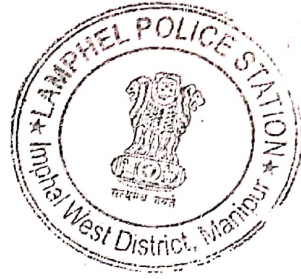
