Today, i.e. the 1st March, 2026 at about 11:05 PM, received information from SP Imphal West Control Room that two brothers of the same family tussled violently at their residence at Moirangkhom Loklaobung. Based on the information, immediately a team of Imphal-PS led by ASI N. Lenan Singh and ASI Th. Saratchandra Singh rushed at the spot. On arrival at the spot, the police team found two brothers namely Sanjoy Waikhom (42 yrs) S/O (L) W. Umakanta Singh and Waikhom Ratan (46 yrs) S/O (L) W. Umakanta Singh of Moirangkhom Loklaobung tussled violently under the influence of alcohol. Immediately the police team intervene and pacify the family dispute. However, the local people informed that Waikhom Ratan (46 yrs) possessed one unauthorised pistol. The police team tactically conducted an intensive search at the living room of Waikhom Ratan (46 yrs) and found one 9 mm Pistol bearing body No. 18306064 and the same was seized on production by Waikhom Ratan (46 yrs) but no licence or documents could not be produced regarding the weapon. Hence, he was arrested for possessing an unauthorised pistol.

Hence, a suo-mottu case under FIR No. 62(03)2026 IPS U/s 313/351(2) BNS & 25(1-B) A. Act has been registered for investigation.
