Subject: Report on destruction of illicit poppy cultivation at Suangkuang Hill Range
under Singngat Sub-Division, Churahcnadpur today i.e. 16th January, 2026.

Ref :- No. B-16/14/SP-CCP/2012/218 dated: 15/01/2026.

Sir,

I, the undersigned would like to report that on 16th January,2026, a combined team comprising of Executive Magistrate, District Police led by SDPO/Singngat, 1st IRB, NAB and Forest Department team destroyed illegal poppy cultivation at Suangkuang Hill Range, Singngat Sub-Division, Churachandpur from 01:00 pm to 04:00 pm. Total area of illegal poppy cultivation destructed is estimated to be 10 acres approximately. During the operation, no arrest could be made as the cultivators were not known. However, some of the materials used in the cultivation like salt, urea, sprayers etc were destroyed and burnt and 05 pieces of poppy plants with pods have been seized in the presence of witnesses.

The illegal poppy cultivation destroyed is estimated to be worth Rs. 45,00,000/- (forty five lakhs) approximately.

The report along with the seized poppy pods is hereby submitted for further necessary action please.
